Lourdes Academy **enrollment fees** are annual, non-refundable, per student. The fees are \$110 for each new and \$100 for each returning student.

An annual **technology fee** of \$150 per student in grade 4K-12 offsets the cost of a one-to-one Chromebook, case and resources that assist in-person and virtual learning.

Athletic and activity fees are included in the tuition cost.

Fees

FACTS is used for admission, enrollment, financial aid and payment plans. An annual one-time FACTS fee of \$20 or \$50 applies depending on the payment plan selected. A convenience fee is also charged for all credit/debit card payments on FACTS.

Additional:

Some lunch options in grades 5-12; snack milk in grades 4K-5 and specific high school courses all may have additional fees.

Discounts

Multiple Student Discount:

- 2nd student – deduct \$150 from total family tuition cost
- 3rd student – deduct \$250 from total family tuition cost
- 4th student – receives 50% discount on in-parish tuition rate
- 5th or more – in parish tuition rate is free (applied to youngest students)

Payment in Full:

2% discount deducted from tuition paid in full by 8/19/22.

Referral Program:

25% tuition credit for families who refer a new student that enrolls at Lourdes. This credit is applied to the oldest student tuition.

Parish Membership:

Enrolled students who are active members of Most Blessed Sacrament, St. Jude the Apostle, St. Mary – Omro or Winneconne, and St. Raphael the Archangel parish receive a \$1,500 deduction in tuition. This is made possible by the support these parishes provide to Lourdes Academy.

Financial Aid:

All system families are eligible to apply for financial aid annually. FACTS Financial Aid conducts our financial need analysis, a \$35 fee applies. Applications are due by April 15, 2022.

Wisconsin Parental Choice Program (School Choice Vouchers):



Once accepted into the WPCP, student tuition is covered through graduation. Application period for the 2022-23 school year is February 1 – April 21, 2022. For more info scan the QR code to the left.

SCRIP:

Offset tuition with the purchase of these gift cards. 70% profit from Scrip purchases goes to tuition, 30% goes to Lourdes for general operations.

Wisconsin Tax Deduction:

Wisconsin taxpayers may be able to claim their paid private and religious school tuition expenses up to \$4,000 for each dependent child in grades K-8 and up to \$10,000 for each dependent child in grades 9-12.

529 Tuition Savings Program:

Private and Religious school families can use 529 college savings account to cover K-12 tuition. Talk to your tax or investment advisor to learn how you can use this tool.

Summer Student Employment:

Temporary summer employment is available for students in grades 9-12. We hire about 10-12 students a summer to assist with cleaning, painting and other maintenance duties.
